CINCINNATI RECREATION COMMISSION

Sandy Richardson described services provided by the Bond Hill Recreation Center and welcomed Roselawn residents to participate. Fliers provided for upcoming activities at the center.

CPOP

Susan Glas encouraged members to write the police department encouraging reinstatement of neighborhood officers. They are also working with landlords to discourage littering. She announced the next meeting to be held on October 17, 2006 at 6:30. If the substation is unavailable, a sign will be on the door announcing the meeting location.

COMMITTEE REPORTS
